The Constitution of the Republic of Uzbekistan defines the right of citizens to elect and be elected, the basis of the national electoral system and the basis of these rules and norms, enshrined in the Universal Declaration of Human Rights, the International Covenant on Civil and Political Rights and other international legal documents ratified by Uzbekistan, independence, legitimacy, transparency and fairness. During the elections in our country, the President has done a great job of holding the elections in a transparent and fair manner. Before the start of the electoral process, a special working group was formed to pre-select those who work in special districts and precincts. Elected future chairmen of districts and districts, deputies and employees were trained by our highly qualified scientists. The aim of the training was to eliminate the problems arising in the electoral process and prevent shortcomings, correct and legal organization of elections.

President Shavkat Miromonovich in his book "From national revival to

national elevation" describes the deputy in this way. "We all know that being a deputy is an activity that requires a lot of intellectual potential, hard work, research and responsibility.

First of all, a deputy must always live with the pain of the people, be an example for others, solving problems that bother people. , Calls on the Legislative Chamber not to remain indifferent to any of our laws and to be active in their implementation in accordance with the interests of the people with their independent opinion.

Article 117 of the Constitution states that citizens of the Republic of Uzbekistan have the right to elect and be elected to representative bodies of state power, that each voter has one vote, the right to vote, equality and freedom of expression are guaranteed by law.

The main procedures, rights and obligations of voters, observers, candidates, political parties and their authorized representatives, representatives of the media, proxies and self-government bodies of citizens

in the electoral process and legal guarantees for their protection are set out in the Electoral Code of the Republic of Uzbekistan. in detail.

In order to ensure transparency and openness of the upcoming elections, our legislation provides that media representatives must cover all activities related to the preparation and conduct of elections, be present at polling stations on election day, including.

Another noteworthy aspect is that the right to be present at the vote count is strictly defined.

Last year's elections were held under the slogan "New Uzbekistan new elections". The highlight of these elections was the participation of 825 observers from 10 international organizations from about 50 countries. This, of course, shows that our country is recognized in the world. Observers were present at all stages of the electoral process. What struck them was the openness and transparency of the electoral process, competition between parties and the fact that they were directly covered in the media.

After the elections, observers expressed good opinions, suggestions and recommendations. Due to the shortcomings, the recommendations of the election commissions and the population were taken into account, aimed at increasing the electoral culture and the role of political parties. In previous elections, the most important aspect of these elections was the formation of an electronic list. Its main useful aspect is that now one person can register from one place in

order to vote once, and not for one family, and there are no shortcomings in the formation of the voter list. Another important aspect is that the increase in women's participation in parliamentary elections this year was different from previous elections. According to him, out of 150 deputies elected to the Legislative Chamber of the Republic of Uzbekistan, 48 or 32% are women, 39 or 26% are former deputies of the Legislative Chamber. It is no exaggeration to say that this is a practical confirmation of the laws adopted in our country. Our Law No. 562 "On guarantees of equal rights and opportunities for women and men", September adopted on Chapter 4. Guarantees of equal rights and opportunities for women and men in the exercise of electoral rights.

Article 18. Ensuring equal rights and opportunities for women and men in the exercise of electoral rights

Women and men have equal rights to elect and be elected to representative bodies of power.

Political parties ensure equal rights and opportunities for women and men when nominating candidates for deputies of the Legislative Chamber of the Oliy Majlis of the Republic of Uzbekistan and local Kengashes of people's deputies.

Article 19. Ensuring equal rights and opportunities for women and men in the formation of election commissions

Equal rights and opportunities for women and men are ensured during the formation of the Central Election Commission of the Republic of

Uzbekistan, regional, district, city, district and precinct election commissions for elections and referendums. It is no exaggeration to say that this has found expression in practice.
