The World Tourism Organization (WTO) has identified trends in the development of ecotourism, and by 2020 ecotourism is one of the five main strategic directions. In recent years, the share of ecotourism in the global tourism industry has grown steadily, reaching an annual growth rate of 30 percent.

The ecological direction of tourism actually began in the 70s of the twentieth century. In 1972, tourist guides were organized for the inhabitants of the Scandinavian countries, who watched and studied whales. The fact that the proceeds from this tourism were used to protect the whales was also recognized by the ecotourism guide [5]. In the 80s of the twentieth century, the idea of using nature in environmentally friendly ways for recreational purposes was promoted in Europe and America, and the concepts of "green tourism" and "ecotourism" arose, balancing environmental, economic and requirements. To make the tourism industry a leading sector of the economy, Uzbekistan is consistently carrying out reforms to develop all types of tourism, including ecotourism. Over the years of independence, more than 20 regulatory legal acts have been adopted for the development of tourism in Uzbekistan. In particular, the Decree of the President of the Republic of Uzbekistan dated February 7, 2017 "On the Strategy for the Further Development of the Republic of Uzbekistan" [1], the Decree dated August 16, 2017 "On Priority Measures for the Development of Tourism in 2018-2019" were raised to a new level. According to this decision, in addition to the traditional tourism sectors, it is planned to

development of new tourist routes, and the expansion of the range of services. In 1993, Uzbekistan became a member of the World Tourism Organization (WTO), which unites more than 120 countries. Uzbekistan is also a member of the WTO European Commission. In 1994, Uzbekistan participated in the X session of the Assembly of the World Tourism Organization in Bali, Indonesia, with its projects in the field of tourism [7]. In the early years of the development of tourism in the Republic of Uzbekistan, the main focus was on traditional types. This has led to the development of historical and pilgrimage tourism in our country. Judging by the tourism potential of Uzbekistan, our country has the opportunity to develop those types of tourism that are developing in the world. We also see that the legal documents related to tourism are not fully developed, secondly, currency conversion has not been liberalized, and thirdly, the creation of favorable conditions for visiting the Republic of Uzbekistan by foreign citizens and simplification of the visa regime has not been introduced. In order to develop ecotourism and tourism in the Republic of Uzbekistan and create a world-class tourism industry in the future, on December 2, 2016, President Shavkat Mirziyoyev signed a Decree accelerate measures to tourism development in Uzbekistan" and a Resolution State Committee for Development "On Tourism Development" in the country became a solid basis for the development of the tourism industry, including ecotourism on a programmatic basis [4].
